- AI processing services (e.g., OpenAI)
- Accounting platform integrations (e.g., Intuit QuickBooks)

These providers only process data as necessary to deliver our services.

We may disclose data if required to comply with applicable laws or legal processes.

5. Data Storage and Security

We implement industry-standard security measures to protect your data, including:

- Secure cloud infrastructure (AWS)
- Encryption in transit and at rest where applicable
- Access controls and role-based permissions
